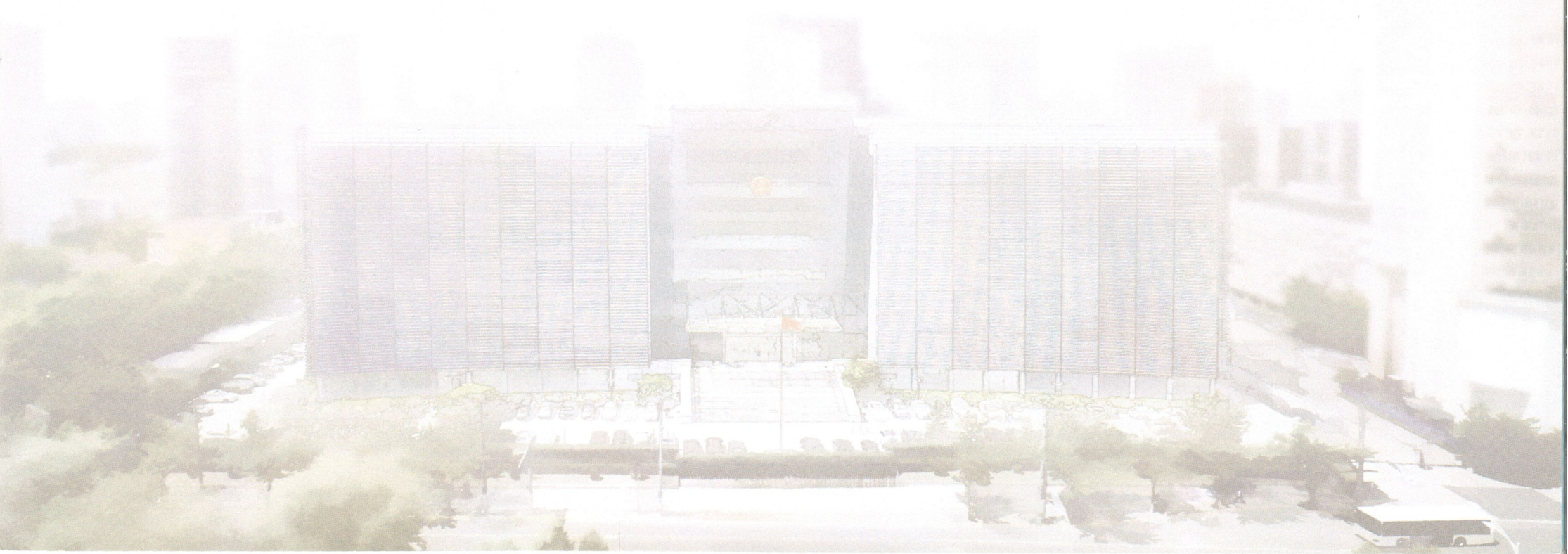


# 前言

为对标国际一流金融司法水平，优化上海国际金融中心法治化营商环境，经最高人民法院批准，上海市高级人民法院聘任了首批包括8名国内专家和7名外籍专家在内的总计15名国际金融法律专家。来自国内外的专家在各自研究领域均享有较高声誉，将在金融法律问题咨询、司法文件论证、工作机制建议及国际交流等方面为上海法院金融审判工作提供专业支持。

## Foreword

To benchmark against the highest level of international financial and judicial practices and optimize the law-based business environment of the Shanghai International Finance Centre, the Shanghai High People's Court has secured approval from the Supreme People's Court to hire the first cohort of 15 international financial legal experts, including eight experts from China and seven from overseas. These domestic and foreign experts hold high reputations in their respective fields of research, and will provide professional support for the financial adjudication work of Shanghai courts. Their support will cover consultancy on financial legal issues, proof of judicial documents, recommendations on working mechanisms, and international exchange.





## 乔治·阿法奇 Georges Affaki

乔治·阿法奇现为法国巴黎大学法学教授，教授国际银行法和争端解决。作为一名特许仲裁员，阿法奇教授同时担任国际投资争端解决中心仲裁员和调解员小组成员、国际统一私法协会基金会理事、沙特商业仲裁中心董事会成员。他曾在国际商会仲裁院任职两届。阿法奇教授现任国际商会银行委员会主席，在其创立的国际商会银行委员会法律委员会担任主席。他领导或参与了转型经济体在信贷和仲裁法方面的多项法律改革。



阿法奇教授曾主持P.R.I.M.E.金融仲裁规则的修订工作，共同主持国际商会金融机构和国际仲裁特别小组。他也曾任法国仲裁委员会银行和金融事务仲裁工作组组长以及国际法协会外国银行分行国际管辖权决议报告员。在国际知名法律评级机构钱伯斯榜单中，阿法奇教授因其在金融监管和诉讼方面的专长，始终是法国最受欢迎的仲裁员之一。阿法奇教授被法国总理任命为法国对外贸易顾问，并曾获欧洲跨学科研究奖。

Georges Affaki is a Professor of law at the University of Paris, France, where he teaches international banking law and dispute resolution. He is a Chartered Arbitrator, a member of the ICSID Panels of Arbitrators and Mediators, a Governor of the UNIDROIT Foundation, and sits on the Board of Directors of the Saudi Center for Commercial Arbitration. He served on the ICC International Court of Arbitration for two terms. He is the Chairman of the Banking Commission of ICC France, and chairs the Legal Committee of the ICC Banking Commission that he founded. He led or participated in several law reforms in transition economies in relation to credit and to arbitration laws.

Professor Affaki chairs the revision of the P.R.I.M.E. Finance Arbitration Rules and has co-chaired the ICC Task Force on Financial Institutions and International Arbitration. He also chaired the French Arbitration Committee working group on Arbitration in Banking and Financial Matters. He acted as Rapporteur for the International Law Association Resolution on international jurisdiction over foreign bank branches. He is consistently ranked by Chambers and Partners amongst France's Most in Demand Arbitrators and for his expertise in financial regulation and litigation. Professor Affaki was nominated Foreign Trade Counselor of France by a Decree of the Prime Minister and was awarded the European Prize for Interdisciplinary Research.
